Public engagement activities are planned throughout the duration of the project. To date, the study has developed alternative improvement concepts and presented the comparative analysis results at the first community meeting for public feedback. Since the first community meeting, Orange County has selected a recommended improvement concept and the study team has refined the study recommendations. This community meeting will provide the public, agency staff, elected officials, and other interested stakeholders the opportunity to review and provide input on the recommended improvement concept. A tentative schedule of upcoming activities is included in this newsletter.

### What is the University Boulevard Pedestrian/Cyclist Safety Study?

Orange County is undertaking the University Boulevard Pedestrian/Cyclist Safety Study to address the safety and needs of the pedestrians, cyclists, and transit users along the study corridor, while observing the current efficiency of the roadway.

This corridor is home to various businesses, residences and institutions that promote bicycle and pedestrian activity. The study objective is to provide both project-wide and location-specific safety, accessibility, comfort, and convenience accommodations for pedestrians, cyclists, transit patrons, motorists and freight handlers of all ages and abilities.

### What are the project limits?

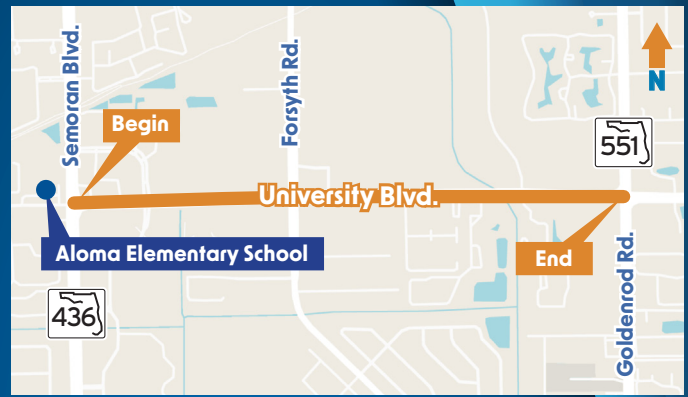
The study corridor is approximately 1.25-miles in length, along University Boulevard, from Semoran Boulevard to Goldenrod Road. The study area includes the general areas to the north and south of the corridor.
